COMPONENTS	<p>The seat and backrest are made of curved plywood, padded with fire retardant foam and upholstered with fabrics chosen by the customers. The upholstery on our chairs is made of flame-retardant fabric and flame-resistant foam.</p> <p>Glidors are made of plastic material, inserted into pre drilled holes on leg.</p> <p>Packaging is made of an undulated double wave cardboard box and protective elements.</p> <p>The article has passed the tests required by the rules: EN 1728:2012+AC:2013 Seat and back static load test EN 1728:2012+AC:2013 Seat and back fatigue test</p>
